Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none">• Social Security number and income• Account balances and credit history• Credit scores and transaction history <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>		
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons 1834 Investment Advisors chooses to share; and whether you can limit this sharing.

What we do

How does 1834 Investment Advisors protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does 1834 Investment Advisors collect my personal information?

We collect your personal information, for example, when you:

- open an account or deposit money;
- direct us to buy securities or direct us to sell your securities;
- enter into an investment advisory relationship.

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only:

- sharing for affiliates' everyday business purposes— information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more information on your rights under state law.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to you alone unless you tell us otherwise.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include companies with a common corporate identity of Old National Bancorp such as Old National Bank, and its successor entities.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *1834 Investment Advisors does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *1834 Investment Advisors doesn't jointly market.*

Other important information

Do Not Call Policy: This notice is the 1834 Investment Advisors Do Not Call Policy under the Telephone Consumer Protection Act for all consumers. 1834 Investment Advisors maintains an internal Do Not Call preference list. Do Not Call requests will be honored within 30 days and will be effective for at least five years from the date of request. No telemarketing calls will be made to residential or cellular phone numbers that appear on the 1834 Investment Advisors Do Not Call list.

Call Monitoring and Recording: If you communicate with us by telephone, we may monitor or record the call.

California, North Dakota and Vermont Residents: We will not share your information with companies outside of 1834 Investment Advisors (including with our affiliates) except as permitted by law, which includes to service your account or with your consent. We will not share information under a joint marketing agreement as defined above without your consent.
